As you know slavery was introduce to america in the early 1619 by the Europeans. During that time America was split into two parts. the north and the south, the north found the slaves unprofitable. But the south found the slaves useful because the african american are skillful at agriculture and craftsmen. which they are more better and skillful than indentured servants, native americans, and white people that once was a choice for slavery. Amending the slave trade in Washington D.C, the Fugitive Slave Act, California entered the Union as a free state, a boundary between New Mexico and Texas, and a territorial government was created in Utah. Due to the conflict between the North and the South, they both agreed on that there will be no slavery when they get new land and expand.

Throughout my research, I found out during slavery the slaves creates their own cultures/ traditions. They created cultures/ traditions such as dancing, singing, and preaching. Due to the lack of education, African Americans can not read so they ended up singing and dancing. They tried and managed to keep the group together because the slaves family member, relatives are all scattered around due to the slavery market.

Decades later, the period of the post-bellum and the antebellum began. The post bellum period the African American was considered "free" but some of them was still under their owner's control. This problem mostly happens in the South. The African

American was still under restriction because all the of work that they wanted to do was under white man. Which, the white mans did not make it easy for the African American to get a decent job and life. Luckily, in the 1800s it became the antebellum period. This is the period where African Americans can live like a normal life like everybody else. No more getting beaten up, yelling, being under control, etc. They get to own lands, enroll in the Civil War, and get a job. They were too selfish to pay people to cultivate their crops so they can make money. But now since slavery is banned from the United States, slavery is never going to active again.
